

TOWN OF GRAFTON ORDINANCE NO 2010-03

**TOWN OF GRAFTON ORDINANCE RELATING TO THE
SPEED LIMIT AND STOP SIGNS ON SPECIFIED TOWN ROADS**

WHEREAS, The Town of Grafton has the authority to modify speed limits on roads and highways within its jurisdiction pursuant to WIS. STAT. §349.11 of the Wisconsin State Statutes; and

WHEREAS, The Town of Grafton has the authority to regulate stop signs on roads and highways within its jurisdiction pursuant to WIS. STAT. §349.065 of the Wisconsin State Statutes; and

WHEREAS, a Notice of Public Hearing before the Town Board was duly published in the _____ on _____, 2010 and _____, 2010 as required by Title 9.1.11 of the Code of Ordinances, Town of Grafton, Wisconsin; and

WHEREAS, a Public Hearing was held before the Town Board on _____, 2010 regarding the proposed Amendments to the Town's Code of Ordinances; and

WHEREAS, this Ordinance requires the need for several minor modifications (section numbering, page numbers, etc.) to the existing text contain in Title 8 of the Town of Grafton's Code of Ordinances; and

WHEREAS, based on the above, it is deemed in the best interests of the Town of Grafton that the Ordinances contained in the Town of Grafton's Code of Ordinances regulating speed limits and stop signs in the Town of Grafton be modified and amended in the manner herein set forth.

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Grafton does hereby ordain as follows:

SECTION 1. An Ordinance establishing a speed limit on the following streets is hereby created and added to Section 8.1.2.04 Speed Limits of the Town of Grafton Code of Ordinances as follows:

The maximum permissible speed shall be Twenty-five (25) Miles Per Hour on the following streets:

SECTION 3. Section 8.1.2.02 and Section 8.1.2.04 of the Town of Grafton Code of Ordinances is hereby amended as provided below:

Delete the following:

- 8.1.2.02 Stop Signs
(1) Cheyenne Avenue at Falls Road
(2) Fox Lane at Cheyenne Avenue
(11) W. Ridgewood Court
- 8.1.2.04 Speed Limits
(1) A Forty-five (45) Mile Per Hour Speed Limit On The Following Highways:
(a) Lake Shore Road
(3) A Thirty (30) Mile Per Hour Speed Limit On The Following Highways:
(a) The north side of the Cedar Creek Road from its intersection with CTH O, westerly to its intersection with 5th Avenue.

Amend the following:

- 8.1.2.02 Stop Signs
(3) Lancaster Court at Ulao Parkway
- 8.1.2.04 Speed Limits
(4) A Twenty-five (25) Mile Per Hour Speed Limit On the Following Highways:
(i) Prairieview Lane ~~on the West side (south bound.)~~

SECTION 4. Except as hereinabove specifically modified and amended, the Code of Ordinances, Town of Grafton, Wisconsin, shall remain in full force and effect exactly as originally adopted and previously amended. All ordinances or parts of ordinances inconsistent with or in contravention of the provisions of this Ordinance are hereby repealed.

SECTION 5. The Ordinances provided herein shall take effect and be in full force from and after its passage and publication or posting.
