



**Town of Grafton Ordinance No. 2013-07**

**TOWN OF GRAFTON ORDINANCE AMENDING  
TITLE 8 – MOTOR VEHICLES AND TRAFFIC;  
CHAPTER 1 – TRAFFIC AND PARKING  
TO REDUCE THE SPEED LIMIT ON EDGEWATER COURT, EDGEWATER DRIVE,  
AND EDGEWATER ROAD FROM 35 MPH TO 25 MPH**

**WHEREAS**, The Town of Grafton has the authority to modify speed limits on roads and highways within its jurisdiction pursuant to WIS. STAT. § 349.11 of the Wisconsin State Statutes; and

**WHEREAS**, a Notice of Public Hearing before the Town Board was duly published in the *Ozaukee Press* on September 19, 2013 and September 26, 2013; and

**WHEREAS**, a Public Hearing was held before the Town Board on October 9, 2013 regarding the proposed Amendments to the Town’s Code of Ordinances; and

**WHEREAS**, based upon the above, it is deemed in the best interests of the Town of Grafton that the ordinance contained in the Town of Grafton’s Code of Ordinances regulating the speed limit on Edgewater Court, Edgewater Drive, and Edgewater Road be modified and amended in the manner herein set forth.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Board of the Town of Grafton, Ozaukee County, Wisconsin, that Section 8.1.2.04(B)(3) of Title 8, Chapter 1, Traffic and Parking, of the Town Code is hereby amended as follows:

**8.1.2.04 Speed Limits**

(B) Speed Limits Increased or Established.

The speed limits are increased or established as hereinafter set forth in this subsection upon the following streets or portions thereof between the limits designated:


