#### 2.1.1 Legal Status.

The Town of Grafton is a body corporate and politic, with those powers granted by law. The Town shall be designated in all actions and proceedings by its name, as the Town of Grafton. State Law Reference: Section 60.01(1), Wis. Stats.

#### 2.1.2 General Town Powers.

The Town may:

#### **2.1.2.01** Sue and be Sued

## 2.1.2.02 Acquire and Hold Real and Personal Property For Public Use and Convey and Dispose of the Property

## **2.1.2.03** Enter into Contracts Necessary for the Exercise of Its Corporate Powers State Law Reference: Section 60.01(2), Wis. Stats.

### 2.1.3 Village Powers.

The Town Meeting having, by resolution at an Annual Meeting held on April 4, 1978, directed the Town Board to exercise all powers relating to villages and conferred on village boards by Chapter 61, Wis. Stats., the Town shall have said powers through its Board. State Law Reference: Sections 60.10(2)(c), 60.22(3) and Ch. 61, Wis. Stats.

#### 2.1.4 Voter Registration.

Pursuant to the provisions of Sec. <u>6.27</u>, Wis. Stats., registration shall be required for all primaries and elections in the Town of Grafton.

#### 2.1.5 Polling Place.

The polling place for all wards shall be the Grafton Town Hall, 1230 11th Ave. Grafton, WI. State Law Reference: Section 5.25(2), Wis. Stats.

#### 2.1.6 Election Poll Hours.

The voting polls in the Town of Grafton, Ozaukee County, Wisconsin, shall be open from 7:00 a.m. to 8:00 p.m. for all elections.

State Law Reference: Section 6.78(2), Wis. Stats.

#### 2.1.7 Number of Poll Workers.

The Town Clerk is authorized to determine the number of poll workers needed on election days.

#### 2.1.8 Town Wards.

Five Town Wards shall be formed into Ozaukee County Supervisor Districts as follows:

#### 2.1.8.01 Ward 1

Ward 1 will be formed from a portion of County Supervisory District 9 and combined with wards from the Town of Cedarburg and be comprised of census blocks: 4004, 4005, 4006, 4007, 4008, 4009, 4010, 4011, 4014, 4059, 4060, 4061, 4062, 4064, 5014, 5015, and 5016.

#### 2.1.8.02 Ward 2

Ward 2 will be formed from a portion of County Supervisory District 10 and be comprised of census blocks: 1017, 1018, 1026, 1027, 1028, 1029, 1030, 1031, 1032, 1033, 1034, 1035, 1036, 1037, 1038, 1039, 1062, 1063, 1064, 1070, 1071, 1072, 4000, 4001, 4002, 4003, 4015, 4016, 4017, 4018, 4019, 4020, 4021, 4023, 4024, 4025, 4026, 4027, 4028, 4029, 4030, 4031, 4032, 4033, 4035, 4036, 4039, 4040, 4042, 5000, 5001, 5002, 5018, 5020, 5021 and 5027.

#### 2.1.8.03 Ward 3

Ward 3 will be formed from a portion of County Supervisory District 10 and be comprised of census blocks: 1002, 1003, 1005, 1007, 1008, 1009, 1012, 1013, 1015, 1016, 1041, 1042, 1043, 1044, 1045, 1046, 1047, 1048, 1049, 1050, 1051, 1057, 1058, 1065, 1066, 1067, 2030, 2031 and 2058.

#### 2.1.8.04 Ward 4

Ward 4 will be formed from a portion of County Supervisory District 10 and be comprised of census blocks: 1068, 1069, 2025, 2026, 2027, 2033, 2034, 2035, 2036, 2037, 2038, 2039, 2040, 2041, 2043, 2044, 2047, 2048, 2049, 2050, 2051, 2052, 2053, 2059, 2060, 3008, 3014, 3015, 3016, 3018, 3019, 3020, 3021, 3028, 3029 and 3030.

#### 2.1.8.05 Ward 5

Ward 5 will be formed from a portion of County Supervisory District 13 and be comprised of census blocks: 1059, 1060, 2013, 2014, 2015, 2018, 2020, 2021, 2022, 2024, 2028, 2029, 2032, 2055, 3009, 3010, 3022, 3024, 3025, 5001, 5005, 5006, 5015, 5016, 5018, 5023 and 5024.
