**RESOLUTION REQUESTING RELOCATION OF MAILBOXES ON
GREEN BAY ROAD IN THE TOWN OF GRAFTON FOLLOWING RECEIPT
AND REVIEW OF RESIDENT PETITION**

WHEREAS, on or about January 13, 2016, residents living on the east side of Green Bay Road submitted a Petition to the Town Clerk requesting the assistance of the Town Board of Supervisors in their effort to relocate their mailboxes to the east side of the street due to extreme safety concerns;

WHEREAS, at the monthly meeting of the Town Board of Supervisors on January 13, 2016, these same residents appeared at the meeting and, under persons wishing to be heard, advised the Town Board of the hazards they encounter when they attempt to retrieve their mail from the west side of Green Bay Road;

WHEREAS, the residents noted that, even with the reduced speed limit of 35 miles per hour, this section of Green Bay Road is treacherous to cross to access mailboxes, and they implored the Town Board to adopt a resolution requesting the United State Postal Services' immediate relocation of the mailboxes based on the substantial hardship they endure;


WHEREAS, the Town Board of Supervisors has carefully considered the residents' Petition, a copy of which is attached hereto as Exhibit A and incorporated herein by reference, as well as Wisconsin DOT traffic counts; and


WHEREAS, the Town Board agrees with the residents' assessment of the dangers presented by the current location of their mailboxes.

NOW, THEREFORE, BE IT RESOLVED that the Town of Grafton Board of Supervisors does hereby request that the United States Postal Service, and, specifically, the Postmaster for the Cedarburg Post Office, promptly allow for the relocation of the mailboxes as requested by the Town residents pursuant to the hardship delivery exception in § 211.3 of Handbook SP-1, the alternate delivery route option, as described in Domestic Mail Manual chs. 41 and 42, or any other available means to ensure the safety of not only the Town residents but also the U.S. Postal Carriers who deliver mail on Green Bay Road.

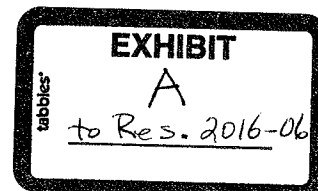
To the Town Board of Grafton:
