



**Town of Grafton Ordinance No. 2009-03**

**TOWN OF GRAFTON ORDINANCE AMENDING Sec. 8.1.2.04(B)(2) OF THE CODE OF ORDINANCES, TOWN OF GRAFTON, WISCONSIN, RELATING TO THE SPEED LIMIT ON EAST SAUK ROAD BEGINNING AT CTH V EAST TO CITY OF PORT WASHINGTON CORPORATE LIMITS**

**WHEREAS**, the Town of Grafton has legal authority, pursuant Wis. STAT. § 349.11(3)(c), to reduce the speed limit from forty-five (45) miles per hour to thirty-five (35) miles per hour on East Sauk Road beginning at CTH V proceeding east and ending at the City of Port Washington Corporate limits; and

**WHEREAS**, the Town of Grafton Board of Supervisors believes it to be in the best interest of the Town to reduce the speed limit to thirty-five (35) miles per hour to protect the health, safety and welfare of the Town of Grafton;

**NOW, THEREFORE**, the Town of Grafton Board of Supervisors does hereby amend Chapter 8, Title 1, Section 2.04(B)(2) of the Code of Ordinances, Town of Grafton, Wisconsin, as follows:

**8.1.2.04 Speed Limits**

(A) State Speed Limits Adopted.

The provisions of Sections 346.57, 346.58, and 346.59, Wis. Stats., relating to the maximum and minimum speed of vehicles are hereby adopted as part of this section as if fully set forth herein, except as specified by this Section pursuant to Section 349.11(3)(c), Wis. Stats., where the Town Board has determined that the statutory speed limits are unreasonable, unsafe and imprudent and has modified such limits.

(B) Speed Limits Increased or Established.

The speed limits are increased or established as hereinafter set forth in this subsection upon the following streets or portions thereof between the limits designated:

- (1) A Forty-five (45) Mile Per Hour Speed Limit On The Following Highways:
  - (a) Lake Shore Road.
- (2) A Thirty-five (35) Mile Per Hour Speed Limit on the Following Highways:
  - (a) East Cedar Creek Road

- (b) East River Road
- (c) Falls Road between the point 1/3 mile east of the eastern limits of the Village of Grafton and the intersection of Falls Road and Port Washington Road
- (d) High Bluff Drive
- (e) Lake Shore Road
- (f) Maple Road from Cedar Creek Road to Cedar Sauk Road
- (g) Maryglade Drive
- (h) Pleasant Valley Road
- (i) River Bend Road
- (j) Terminal Road
- (k) Ulao Parkway from Highway 32 to Highway W
- (l) Ulao Parkway from Hwy 32 to Lakeshore Road
- (m) East Sauk Road beginning at CTH V proceeding east and ending at the City of Port Washington Corporate limits.

This Ordinance shall be in full force and effect upon its passage and posting as provided by law.
