**Town of Grafton Ordinance No. 2012-04**

**AN ORDINANCE AMENDING  
TITLE 2, GOVERNMENT AND ADMINISTRATION,  
CH. 4, TOWN OFFICERS AND EMPLOYEES,  
OF THE CODE OF ORDINANCES, TOWN OF GRAFTON, WISCONSIN,  
TO CONFORM WITH 2011 WIS. ACT 115 AMENDMENTS TO WIS. STAT. CH. 60**

**WHEREAS**, the terms of elected Town Officers have previously begun on the 2<sup>nd</sup> Tuesday in April; and

**WHEREAS**, elected Town Officers will now have their terms of office commence on the 3<sup>rd</sup> Tuesday in April due to recent state election law changes; and

**WHEREAS**, it is deemed to be in the best interest of the Town of Grafton that the Municipal Code of the Town of Grafton be further modified and amended to conform to the same; and

**WHEREAS**, 2011 Wis. Act 115 provides that the Town Board may enact an ordinance providing that the terms of any elected officers in the Town who were elected to serve for terms expiring on the 2<sup>nd</sup> Tuesday of April may be extended to the 3<sup>rd</sup> Tuesday in April in the same year in which the terms would have otherwise expired.

**NOW, THEREFORE**, be it hereby ordained by the Town Board of the Town of Grafton that the terms of elected Town Officers be extended until the 3<sup>rd</sup> Tuesday of April in the same year in which the terms would have otherwise expired, and that the Town Code of Ordinances, Title 2, Chapter 4 be amended as follows:

Section 2.4.1 of the Town of Grafton Code of Ordinances is hereby amended as provided below by adding the underlined language and deleting the language struck out:

...

**2.4.1.04 Term of Office**

- (A) Every elected Town officer shall hold the office for two (2) years.
- (B) The regular term of elected Town officers, other than the Town Assessor, if elected, commenced on the ~~second (2nd)~~ third (3rd) Tuesday of April in the year of their election.

This ordinance shall be effective upon publication or posting by the Town Clerk as required pursuant to WIS. STAT. § 60.80.
